The Aim of the Conference

The aim of the conference is to explore the critical role of Civic and Citizenship Education in preparing individuals for active and responsible participation in today's complex and rapidly changing societies. The discussion will focus on the importance and characteristics of Civic and Citizenship Education, including its essential elements such as democratization, interpersonal communication and participation in various contexts (school, community, and global).

The conference will be an opportunity to:

- Present results from the secondary analysis of the international ICCS 2022 (International **Civic and Citizenship Education Study)**
- Engage in broader discussions on crucial topics relevant to modern societies, including:
 - 1. Democracy, parliamentarism and citizenship: how young people perceive the political system
 - 2. Democratization in school practice: interpersonal relations, school climate and school culture
 - 3. Participation, engagement and creating a motivating context for the development of civic activism inside and outside the school
 - 4. Digital technologies and media literacy in modern educational systems and societies
 - 5. Trust, attitudes on civic issues and value orientations among young people
 - 6. Social diversity in education: inclusion, gender equality and minority human rights
 - 7. Environmental, social and economic sustainability

We encourage submissions from researchers, educators and policymakers from all sectors (academia, education, government, and NGOs) to share their empirical findings, theoretical insights, and practical experiences related to these themes.

Style Guidelines for Conference Abstracts

- The preferred length of the abstract is 1800 characters or 250 words with spaces (maximum limit), not including the title, authors' names, affiliations, keywords (up to five keywords).
- Abstracts should be submitted in English (font: Times New Roman, 12pt, with 1.5 line spacing).
- Abstracts should comprise a demonstration of the relevance of the research problem, a brief description of the research method and data analysis procedures, a description of the key findings, conclusions, and scientific implications and/or implications regarding education policies and practices.
- Conference abstracts should be sent to the following email address: ierconference2024@ gmail.com
- All abstracts will be published in the Book of Abstracts. Additionally, selected full papers will be published after the Conference.
- The Conference will be accredited as a form of professional development of educational workers.
